Falls Road Dance Studio COVID-19 Guidelines

- Upon arrival all dancers, gymnast and parent chaperones will get their temperature taken and be asked a series of questions to ensure everyone is healthy. See drop off procedures on page 2 for more details.
- All dancers/gymnasts should arrive dressed ready to go. All dance shoes/water bottles should be kept in a bag. They will be directed where to put their things upon arrival.
- Individuals shall maintain 6 feet of physical distance, wherever and as often as possible. There will be marked spaces on the floor to assist in this.
- Staff and parent chaperones must wear face coverings.
- Dancers and gymnasts age 2 and older should wear face coverings when able to be worn safely. Children that are not developmentally ready will be exempt.
- Dancers and gymnasts ages 2 through 5 must have one parent with them at all times during the class to help with social distancing if they are unable to do this on their own.
- No spectators; no one in the building except dancers, gymnast and/or their one chaperone if 5 and under
- No siblings may be present when it is not their class time
- The playground is closed during dance and gymnastics as these are used by the preschool and need to be cleaned between uses
- Surfaces, props and equipment will be cleaned between classes

Drop off and Pick Up Procedures

1. Older dancers/gymnasts should be dropped off, dressed, shoes and face mask, at their class door on the porch. Siblings and parents should remain in their car. No one will be using the middle, lobby door. For students age 5 and under one chaperone and the student should go to their class door on the porch. Please stand in the socially distanced place markers on the porch.
2. A staff member will use a touchless thermometer to check the student and chaperone temperature. If it is 100° or over, they will need to return home.

Staff will ask parent/guardian the following questions:

- Has the student or anyone at home had symptoms of Covid 19?
- Has anyone at the house been exposed to Covid 19 in the last 14 day?
 - If yes to any questions, the student may not attend dance that week and will need to go home.
 - If there is any sign of illness, they may not attend dance that week
 - If illness is noticed during class, they will immediately be asked to leave
- 3. The teacher will then invite the student into class and show them where to stand and place personal items. Chaperones should not take anything into the classroom except their facemask.
- 4. Siblings and parents should remain in the car or may go home and come back at the conclusion of the class. The lobby and all playgrounds will be closed to maintain safety for the preschool.

5. When class is over staff will walk students to the door. Parents should pick-up their child from the door, appropriately social distancing! Students who are 5 and under will have their one chaperone with them that can walk them to their own vehicle.
